Who we are: Silver Arch Family Resource Centre, celebrated its 50th anniversary in 2023 and has continued to uphold its primary objective: "To provide community-based support, information, and advocacy services to individuals, families, and groups in North Tipperary, so as to empower and help people, particularly those who are most disadvantaged, to access services." Silver Arch FRC deliver a diverse range of supports and services, including 'The Thrift Shop' Social Enterprise, rural Early Childcare preschools, the Community Families Programme (previously Community Mothers), Family Support, Parenting Programmes, Partnership with Families, Unity Child & Youth Hub, Social Prescribing, child and adolescent therapeutic services, adult counselling, gambling counselling, and community development outreach projects. These initiatives serve families, older persons, and individuals ranging from 0-100+ years, across our outreach locations in Nenagh, Newport, and Borrisokane.

**Overview:** Silver Arch Family Resource Centre is seeking a dedicated and considerate Home Visitor to join the well-established Community Families (previously Community Mothers) team. Community Families is a home visiting programme that prioritises the parents' relationship with their child, offering tailored support based on individual family needs. Through the programme, parents are connected with a trained Home Visitor who provides support and information from pregnancy until the child reaches 3 years of age. The programme is flexible and adapts to the unique circumstances of each family, offering both individual home visits and community-based group support while fostering connections within the local community.
